The Annual Water Quality Report is for the period of January 1 to December 31, 2018. This report is intended to provide you with important information about your drinking water and the efforts made by the water system to provide safe drinking water.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. Contaminants may be found in drinking water that may cause taste, color or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, color or odor of drinking water, please contact the system's business office at the number provided above.

The elected Board of Directors of the System meets every 2nd Wednesday of the month at 6:30 or 7:00 PM. The meeting is normally held at the Corporations' office located at 2393 County Road 311 in Jarrell, TX. Meeting notices are posted with Bell and Williamson Counties and at the Corporations' office.

Special Notice

Required Language for all community public water supplies:

You may be more vulnerable than the general population to certain microbial contaminants, such as *Cryptosporidium*, in drinking water. Infants, some elderly or immune-compromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk for infections. You should seek advice about drinking water from your physician or health care providers. Additional Health Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Nitrate Advisory – Nitrate in drinking water at levels above 10 PPM is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant you should ask advice from your health care provider.

Exceedance of Fluoride Secondary Constituent Level

This is an alert about your drinking water and a cosmetic dental problem that might affect children under nine years of age. At low levels, fluoride can help prevent cavities, but children drinking water containing more than 2 milligrams per liter (MG/L) of fluoride may develop cosmetic discoloration of their permanent teeth (dental fluorosis). The drinking water provided by your community water system, Jarrell-Schwertner WSC has a fluoride concentration of 2.09 MG/L.

The wells producing the concentration of 2.09 MG/L are located in the southwestern area of the water system and affect 326 of the systems' 1591 connections. Samples collected and affecting the remaining 1265 connections have concentrations of Fluoride below 0.5 MG/L. The Southwestern area is considered to be south of the City of Jarrell of the west side of IH 35, CR314, CR 311, and FM 1105 up to CR 314. This same area also received water from Sonterra MUD in late August 2018 for 2 to 3 days. The volume of water was 223,400 gallons over that period. The reported Fluoride level from Sonterra was 3.79 MG/L.

Dental fluorosis, in its moderate or severe forms, may result in a brown staining and/or pitting of the permanent teeth. This problem occurs only in developing teeth, before they erupt from the gums. Children under nine should be provided with alternate sources of drinking water or water that has been treated to remove fluoride to avoid the possibility of staining and

pitting of their permanent teeth. You may also want to contact your dentist about proper use by young children of fluoride-containing products. Older children and adults may safely drink the water.

Drinking water containing more than 4 MG/L of fluoride (the U.S. Environmental Protection Agency's drinking water standard) can increase your risk of developing bone disease. Your drinking water does not contain more than 4 MG/L of fluoride, but we're required to notify you when we discover that the fluoride levels in your drinking water exceed 2 MG/L because of this cosmetic dental problem.

Source of Drinking Water

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over surface of the land and through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants including synthetic and volatile organic chemicals which are by-products of industrial processes and petroleum production and can also come from gas stations, urban storm water runoff and septic systems.
- Radioactive contaminants which can be naturally occurring or be the result of oil and gas production and mining activities.

Where do we get our drinking water?

The source of drinking water primarily used by Jarrell Schwertner WSC is ground water. The wells draw water from the Edwards Aquifer. Only those areas served by Central Texas Water Supply Corporation are on surface water. The source of their water is Lake Stillhouse Hollow. The Texas Commission on Environmental Quality (TCEQ) completed an assessment of your source water and results indicate that some of your sources are susceptible to certain contaminants. The sampling requirements for your water system are based on this susceptibility and previous sample data. Any detection of these contaminants may be found in this Consumer Confidence Report. JSWSC customers along Royal, Blackberry, East Amity and the Live Oak Subdivision have received water from two outside sources. Those are either Salado WSC noted as Salado in the report or Central Texas WSC noted as CTWSC. JSWSC may take water from Sonterra MUD which is shown as SMUD in the report. Water taken from SMUD is an emergency supply and would influence water quality in an area west and east of IH 35 near County Roads 310 and 311.

Secondary Contaminants

Many constituents such as calcium, sodium or iron which are often found in drinking water can cause taste, color and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas and not the EPA. These constituents are not causes for health concerns. Therefore secondary contaminants are not required to be reported in this document but they may greatly affect the appearance and taste of your water. MCL or maximum contaminant level – the highest level of a contaminant that is allowed in drinking water – MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG or maximum contaminant level goal – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MRDL or maximum residual disinfectant level – The highest level of disinfectant allowed in drinking water – There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

MRDLG or maximum residual disinfectant level goal – The level of a drinking water disinfectant below which there is no known or expected risk to health – MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Not all sample results have been used for calculating the Highest Level Detected because some results may be part of an evaluation to determine where compliance sampling should occur in the future.

In early 2019 the WSC submitted an annual water loss report to the Texas Water Development Board for the time period of January 1 to December 31, 2018. The estimated water loss was 110,851,219 gallons. The WSC does have an on-going program to lessen these losses. The Corporation has continued to grow in 2018. Thirty-six (36) new members were added during the year. No new water facilities were constructed during 2018 however the Corporation did build a new office/warehouse. The office is located on 12.2 acres of land that was owned by the Corporation. The location is 2393 County Road 311. This site is around 2 miles east of IH 35 and Ronald Reagan on County Road 311 or near FM 1105 just north of New Corn Hill. The mailing address on PO Box 40 Jarrell, TX 76537 and the telephone number, 512-746-2114, did remain the same.

As noted last year the Corporation had entered into an agreement to construct and purchase water from the Brazos River Authority through the Lone Star Regional Water Authority. The project will bring 1.5 Million Gallons of treated water per day to the Corporation. This project is well underway and is near 60% completion. At this time, it is expected that the project will be complete in August or September of 2019. The Corporation will begin taking water from this project when it most benefits' the membership.

While the Corporation has seen increased growth over the last couple of years the future growth of the Corporation may see a greater increase. Developers working in the area have taken note of the available land and utilities and are approaching the Corporation for service. These types of developments will bring in subdivisions that will concentrate housing in smaller areas making these areas easy to serve.

Water loss continues to be an issue for the Corporation. Please continue to report any leaks or suspected leaks to our office at 512-746-2114. Our staff will investigate each reported leak and address them in an appropriate manner. If you notice your water pressure is low please contact the office. Even if you do not see a leak this may be a sign of a water leak in your area. For water quality issues please contact the same number and report the problem. The Corporation maintains a website, www.jswatersupply.com. If there is a large area that is experiencing a water outage an explanation should be available on that site as well as instructions of any precautions to take.
