### *Agreement Terms – Jarrell-Schwertner Water Supply Corporation (JSWSC)*

The Applicant hereby agrees to obtain, utilize, and/or reserve service as soon as it becomes available. Upon qualification for service under the terms of the Corporation's policies, the Applicant shall further qualify as a Member, and the Indication of Interest Fee shall be converted by the Corporation to a Membership Fee. The Applicant further agrees to pay, upon becoming a Member, the monthly charges for such service as described in the Corporation's tariff.

Any breach of this agreement shall give the Corporation cause to liquidate, as damages, the fees previously paid as an Indication of Interest. In addition to any Indication of Interest Fees forfeited, the Corporation may assess a lump sum of \$300.00 as liquidated damages to defray any losses incurred. If delivery of service to the requested location is deemed infeasible by the Corporation as part of this project, the Applicant shall be denied Membership. The Applicant may re-apply for service at a later date under the Corporation's policies. For the purpose of this agreement, the Indication of Interest Fee shall be equal to the Corporation's Membership Fee.

Water meters are the property of JSWSC and may only be turned on or off by authorized personnel. It is unlawful for any person or property owner to reconnect or attempt to reconnect service. Such action is punishable by a fine of up to \$1,000 and/or imprisonment. The Applicant acknowledges that JSWSC reserves the right to access meters whenever necessary.

**All new Members are required to pay a \$300.00 Membership Fee before service can be established. All bills are due on the 15th day of each month. A late fee will be applied to all unpaid balances after this date. In the event service is disconnected due to non-payment, an \$100.00 disconnect fee will be charged.**

The Applicant agrees to accept full responsibility for all charges incurred and to notify JSWSC in writing of their intent to cancel service.
